# FOR PARENTS OF CLOSE CONTACTS OF COVID 19 AT COOPERSALE AND THEYDON GARNON C.E. PRIMARY SCHOOL

## Advice for Child to Self-Isolate for 14 Days

## **Dear Parents and Carers of Year 1 pupils,**

We have been advised by Public Health England that there has been a confirmed case of COVID-19 within the school.

We have been advised by the national Test and Trace programme and have identified that your child has been in close contact with the individual who has tested positive for COVID-19. We cannot provide further details of the individual who tested positive for privacy and data protection reasons, but rest assured, a full investigation has been conducted with Public Health England to identify close contacts.

In line with the national guidance we request that your child now stays at home and self-isolates until Tuesday 17<sup>th</sup> November 2020 (14 days after contact).

We are asking you to do this to reduce the further spread of COVID-19 to others in the community.

During this period of isolation, we will provide remote learning for all Year 1 pupils via our School's website. We will be setting up a Year 1 Remote Learning page, within the CURRICULUM tab of the website. This will be provided for Friday 6<sup>th</sup> November through to Monday 16<sup>th</sup> November 2020. We will send a School app notification on Friday 6<sup>th</sup> once plans are posted online. We expect to have Friday's plans ready by 10am tomorrow, followed by weekly plans uploaded no later than Sunday midday, for both weeks ahead. Please be aware that our Year 1 teacher is also absent from School with illness of her own and until her return, planning is being completed by our Phase and Curriculum Leaders of the School. No communication with Miss Hill will be possible until she returns herself from illness. We will of course keep Year 1 parents updated on her return if before the isolation period ends. In Miss Hill's absence, we will arrange for designated staff to be in contact with you for remote learning support. Named staff will be released to you on Monday 9<sup>th</sup> November.

If your child is well at the end of the 14-day period of self-isolation, then they can return to usual activities, including returning to school.

Other members of your household can continue normal activities provided your child does not develop symptoms within the 14-day self-isolation period.

## What to do if your child develops symptoms of COVID 19

If your child develops symptoms of COVID-19, they should remain at home for at least 10 days from the date when their symptoms appeared. Anyone with symptoms will be eligible for testing and this can be arranged via <a href="https://www.nhs.uk/ask-for-a-coronavirus-test">https://www.nhs.uk/ask-for-a-coronavirus-test</a> or by calling 119.

All other household members who remain well must stay at home and not leave the house for 14 days. This includes anyone in your 'Support Bubble'.

The 14-day period starts from the day when the first person in the house became ill.

Household members should not go to work, school/college or public areas and exercise should be taken within the home. If you require help with buying groceries, other shopping or picking up medication, or walking a dog, you should ask friends or family. Alternatively, you can order your shopping online and medication by phone or online.

Household members staying at home for 14 days will greatly reduce the overall amount of infection the household could pass on to others in the community.

If you are able can, move any vulnerable individuals (such as the elderly and those with underlying health conditions) out of your home, to stay with friends or family for the duration of the home isolation period

## **Symptoms of COVID 19**

The most common symptoms of coronavirus (COVID-19) are recent onset of:

- new continuous cough and/or
- high temperature and/or
- a loss of, or change in, normal sense of taste or smell (anosmia)

## For most people, coronavirus (COVID-19) will be a mild illness.

#### How to stop COVID-19 spreading

There are things you can do to help reduce the risk of you and anyone you live with getting ill with COVID-19

## Do

- wash your hands with soap and water often do this for at least 20 seconds
- use hand sanitiser gel if soap and water are not available
- wash your hands as soon as you get home
- cover your mouth and nose with a tissue or your sleeve (not your hands) when you cough or sneeze
- put used tissues in the bin immediately and wash your hands afterwards
